Supporting Implementation at Continental,
Regional, and National Levels



Building on decades of engagement with the Comprehensive Africa Agriculture Development Programme (CAADP), and working closely with partners at national, regional, and continental levels, the International Food Policy Research Institute (IFPRI) will provide evidence-based research, policy support, and capacity development to support implementation of CAADP 2026-2035 toward agrifood system transformation and enhanced food security, resilience, and economic growth.

IFPRI's Longstanding Support to CAADP

The Comprehensive Africa Agriculture Development Programme has been the cornerstone of Africa's agricultural policy framework since the 2003 Maputo Declaration. Over the years, CAADP has evolved to reflect the continent's changing priorities, including ambitious new targets on hunger eradication, poverty reduction, and resilience building introduced by the 2014 Malabo Declaration. The CAADP Strategy and Action Plan 2026-2035 now focuses on intensifying sustainable food production, agro-industrialization, financing, nutrition security, inclusivity, resilience, and governance.

IFPRI has been a key technical partner to CAADP from its inception, supporting the African Union Commission (AUC), AUDA-NEPAD, the Regional Economic Communities (RECs), and national governments. IFPRI has played a leading role in:

- Providing technical support for the design of CAADP roadmaps at continental, regional, and national levels.
- Developing data-driven monitoring frameworks, including the CAADP Biennial Review and the Regional Strategic Analysis and Knowledge Support System (ReSAKSS), which track progress and inform policy decisions.
- Building capacity for evidence-based policymaking by working with policymakers, national research institutions, and think tanks.
- Mobilizing investment through reviews of agricultural public expenditure, investment planning, and impact assessments.

Given IFPRI's deep engagement, strong partnerships, and multilevel presence in Africa, the Institute is uniquely positioned to support CAADP 2026-2035's ambitious vision with an integrated, systemwide approach that ensures policy, investment, and governance reforms are implemented effectively and at scale.



IFPRI's Role and Strategic Approach

IFPRI is uniquely positioned to support CAADP through its:

- Research and knowledge generation – Providing data-driven insights for evidence-based policymaking.
- Technical assistance and policy support – Engaging AU, RECs, and national governments to translate evidence into action.
- Capacity development – Training policymakers and institutions to enhance decision-making.
- Investment and financing support – Aligning public and private resources with CAADP priorities.
- Monitoring, evaluation, and learning – Tracking CAADP commitments and progress.
- Stakeholder engagement and convening – Facilitating dialogue among policymakers, private sector, and development partners.

Implementation Modalities

To effectively support CAADP 2026–2035, IFPRI will adopt the following approaches:

- **Multi-Level Engagement** – Working at regional (AU, RECs), national (ministries, governments), and local (farmer organizations, private sector) levels to support policy dialogue, technical assistance, and action research.
- **Partnerships and Collaborations** – Engaging with AUC, AUDA-NEPAD, AfDB, CGIAR Centers, national research institutions, and think tanks such as ANAPRI to bridge research, policy, and implementation.
- **Policy Outreach and Communication** – Facilitating policy dialogues, publishing research in accessible formats, and advising policymakers on evidence-based agricultural transformation.
- **Monitoring, Evaluation, and Learning** – Supporting CAADP’s biennial review process with data analytics, impact assessment frameworks, and real-time policy monitoring tools.
- **Resource Mobilization** – Co-developing funding proposals with AUC, RECs, and national governments, engaging development partners, and supporting investment alignment for sustainable agricultural development.

IFPRI remains committed to supporting Africa’s agricultural transformation by ensuring that CAADP’s objectives are translated into actionable and scalable solutions. By delivering integrated support packages, IFPRI will work with national governments and regional partners to accelerate progress, ensuring that policies, investments, and innovations result in measurable impacts on food security, economic growth, and resilience.
